**NARRATIVE:**

On 8-16-24 at approximately 11:48am. s/o HOLT received a call from owner of Pittman Security. Dispatching me to investigate a residential break-in. I immediately notified CPD on the situation. Gave them the address . Informed them I was in route. At approx. 12:30pm I Officer HOLT arrived at 7414 S. Princeton. No CPD present. I viewed a tall black male. In front of the property. Getting into a light brown Van. Holding something with a black handle. I really couldn't identify the object; the Individual was holding. But expected the worst that the object could be a weapon. I called CPD the second time. CPD Arrived at approx. 12:45pm I informed CPD the individual could be the suspect to break in of the property. CPD approached the individual. Search him. No weapon was found. The individual Stated he was working for the owner of the property. Two other black males came out of the residence, one tall light completion individual claiming to be partial Owner of the property with some paperwork. One older guy in his 60's dark complexion. The individual that's viewed on the picture breaking in the back of the property.

I Officer HOLT, explained to CPD of the situation that I was knowledgeable of the matter. CPD stated the other party Mr. Patterson was not present and they would have to take the individual that's claiming to be the owner's word. CPD did nothing about any locks broken or and no arrest of trespass was executed. CPD finished talking to the individual claiming to be partial owner. 1:30pm CPD Departed the property. I tried to get pictures of the individuals involved. I was only able to get pics of the truck and no license plate. There were two helpers which were in the van. The picture of the passenger in the van was the individual that broke into the building. I was not able to capture a picture of the driver of the van. The other individual who claimed to be the partial owner of this property (8914 S. Princeton) left the property in an unknown direction, no picture captured. That ends this report.
